## ASSAM ACT No.XXVII OF 1960

THE ASSAM FIXATION OF CEILING ON LAND HOLDINGS (AMENDMENT) ACT, 1959

(As passed by the Assembly)

further to amend the Assam Fixation of Ceiling on Assam Act Land Holdings Act, 1956. I of 1957.

Preamble.

Whereas it is expedient further to amend the Assure Act Assam Fixation of Ceiling on Land Holdings Act, I of 1957.

1956, hereinafter called the Principal Act, in the manner hereinafter appearing;

It is hereby enacted in the Eleventh Year of the Republic of India as follows:—

Short title, 1. (1) This Act may be called the Assam Fixation extent and of Ceiling on Land Holdings (Amendment) Act, 1960. commence-
