No. LGL. 135/93/183.—The following Act of the Assam Legislative Assembly which received the assent of the Governor is hereby published for general information.

#### ASSAM ACT NO. XXII OF 1995

(Received the assent of the Governor on 20th October, 1995)

THE GUWAHATI MUNICIPAL CORPORATION (AMENDMENT) ACT, 1995.

AN

further to amend the Guwahati Municipal Corporation Act, 1969.

Preamble Whereas it is expedient further to amend the Assam Guwahati Municipal Corporation Act, 1969, Act-1 of hereinafter referred to as the principal Act;

It is hereby enacted in the Forty-sixth Year of the Republic of India as follow:—

Short title, extent and commencement.

- 1. (1) This Act may be called the Guwahati Municipal Corporation (Amendment) Act, 1995.
  - (2) It shall have the like extent as the principal Act.
  - (3) It shall come into force at once.

Amendment 2. In the principal Act, in section 5, in subsection 5.

(i) in sub-clause (v), for the existing third proviso, the following provisos shall be substituted, namely;—

"Provided further that the office of the Mayor shall be reserved for the Scheduled Castes, the Scheduled Tribes and women on roster basis, and six persent, four percent and forty percent of the roster points shall be reserved for the Scheduled Castes, the Scheduled Tribes and women respectively in the manner set out in fifth Schedule;

Provided further that the State Government may from time to time review the implementation of reservation and take adequate measures including increase or decrease of percentage mentioned in the preceding proviso,"

(ii) for sub-clause (ix), the following shall be substitued, namely:—

"(ix) The term of office of the Mayor and the A property Mayor shall be one year from the date of the relections."

Insertion 3. In the principal Act, after the Fourth Schedule, of new Schedule, the following shall be inserted as the Fifth Schedule, namely:—

Repcal and saving

- 3. (1) The Guwahati Municipal Corporation Assam (Amendment) Ordinance, 1995 is hereby repealed. Ordinance IV of 1995.
- (2) Notwithstanding such repeal anything done or any action taken under the Ordinance so repealed shall be deemed to have been done or taken under the corresponding provisions of this Act as if this Act came into force on the date the Ordinance came into force.
