THE ASSAM DEPUTY SPEAKER'S SALARIES AND ALLOW-ANCES (AMENDMENT) ACT 1994.

AN

further to amend the Assam Deputy Speaker's Salaries and Allowances Act, 1958.

Preamble. Whereas it is expedient further to amend the Assam Act, Assam Deputy Speaker's Salaries and Allowances XVI of Act, 1958, hereinafter referred to as the principal Act, in the manner hereinafter appearing:

It is hereby enacted in the Forty-fifth Year of the Republic of India as follows:—

Short title and and Deputy Speaker's Salaries and Allowances (Amendment) Act, 1994.

(2) It shall be deemed to have come into force on the firs day of April, 1994 and in respect of Sitting Altowance on and from nineth day of March, 1994.

Amendment 2. In the principal Act, for Section 2, the of Section 2 following shall be substituted, namely:—

1958. "Salary and allowances of the Deputy Spea-

"Salary and allowances of the Deputy Speaker:—There shall be paid to the Deputy Speaker of the Assam Legislative Assembly—

- (i) a salary of two thousand five hundred rupees per mensem;
- (ii) a Sumptuary Allowance of four thousand five hundred rupees per measurem;
 - (iii) a Daily Allowance of two hundred rupees while on Official tour and its halt within the State of Assam:

Provided that the Deputy Speaker of the Assam
Legislative Assembly shall be entitled to draw
double the amount of Daily Allowance entitled
to by the Deputy Speaker within the State whenever
the Deputy Speaker performs the official duties
outside the State of Assam and its halt;

(iv) a Sitting Allowance of one hundred and fifty rapses per day for the entire period of the Assembly Session computing two days before the commencement and two days after the termination of such Session:

Provided that the Sitting Allowance shall not be admissible if the Deputy Speaker of the Assam Legislative Assembly performs the official tour within the State of Assam or outside the State of Assam and its halt during the period of the Assembly Session and such performance of official tour shall be intimated to the Secretary, Assam Legislative Assembly;

- (v) a Parliamentary Assistant Allowance of rapees two thousand per mensem;
- (vi) two hundred litres of petrol for Head Quarter use as fuel; and
- (vii) a Mileage Allowance of two rupees and fifty paise per kilometre as propulsion cost for the use of his official car on official duty."
