ASSAM ACT NO. I OF 1993 (Received the assent of the Governor on 22nd January, 1993)

THE ASSAM TEA PLANTATIONS PROVIDENT FUND (AND PENSION FUND) (AND DEPOSIT LINKED INSURANCE FUND) SCHEME (AMENDMENT) ACT, 1992

AN

further to amend the Assam Tea Plantations Provident Fund (and Pension Fund) (and Deposit Linked Insurance Fund) Scheme Act, 1955.

Preamble. Whereas it is expedient further to amend the Assam
Tea Plantations Provident Fund (and Pension Fund)
(and Deposit Linked Insurance Fund) Scheme Act, 1955
hereinafter referred to as the principal Act, in the manner
hereinafter appearing;

It is hereby enacted in the Forty-third Year of the Republic of India as follows:—

Short title and commence-ment.

- 1. (i) This Act may be called the Assam Tea Plantations Provident Fund (and Pension Fund) (and Deposit Linked Insurance Fund) Scheme (Amendment) Act, 1992.
 - (ii) This shalf be deemed to have come into force with effect from 30th June, 1992.

Amendment of Section 2 of Assam Act M of 1955.

- (i) In clause (d), for the words and figure "Rs.1.600/(Rupees one thousand six hundred)" the words,
 figure and bracket "Rs.3,500/- (Rupees three
 thousand five hundred)" shall be substituted and
 the existing explanation shall be omitted;
- (ii) In clause (f),—
- (a) in the opening line, after the words "tea plantation", the words "or tea factory" shall be inserted:

- (b) in sub-clause (ii) after the word "Scheme" the word "or" shall be inserted
- (c) after sub-clause (ii), so amended, the following new sub-clauses shall be inserted namely:—
 - "(iii) any tea factory manufacturing tea where ten or more employees are employed;
 - (iv) Notwithstanding anything contained in sub-clauses (i), (ii) and (iii) of this clause where it appears to the State Government, whether on an application made to it in this behalf or otherwise, that the employer and the majority of employees in relation to any establishment have agreed that the provisions of this Act should be made applicable to the establishment, it may, by notification in the Official Gazette, apply the provisions of this Act to that establishment on and from the date of such agreement or any subsequent date specified in such agreement".

Amendment of section 10 of Assam
Act X of 1955

3. In the principal Act, in section 10, in sub-section (2), for the term beginning with the words, "in respect of the employees", and ending with the words, "more than six months", the following shall be substituted, namely:—

"Whether in respect of the employees' contributions (deducted from the wages of the employees) or the employer's contributions for a period of more than one month".

Amendment of section 11 of Assam Act Xof 1955

4. In the principal Act in section 11, for the words, "tea estate", the words, "tea plantation or tea factory" shall be substituted

Amendment of Schedule of Assam Act X of 1955

5. In the principal Act, in the Schedule, in item 1 (b), for the words "tea estate", the words, "tea plantation or tea factory" shall be substituted.

Amendment of Assam Act X of 1955 6. Notwithstanding anything contained in sub-section (2) of section 1 of this Act, in the principal Act, in the short title and long title between the term the bracket "(And Pension Fund)" and the word
