## THE ASSAM MOTOR VEHICLES TAXATION (AMENDMENT) ACT, 2003

### ACT

further to amend the Assam Motor Vehicles Taxation Act. 1936.

### Preamble

Whereas it is expedient further to amend the Assam Act Assam Motor Vehicles Taxation Act, 1936, hereinafter No. IX of referred to as the principal Act, in the manner 1936. hereinafter appearing;

It is hereby enacted in the Fifty-Fourth Year of the Republic of India as follows:-

### Short title, extent and commencement.

- 1. (1) This Act may be called the Assam Motor Vehicles Taxation (Amendment) Act, 2003.
  - (2) It shall have the like extent as the principal
  - (3) It shall come into force at once.

### Amendment of Schedule.

2. In the principal Act, in the Schedule, in Article II, for Entry 10, the following Entry shall be substituted, namely:- I Add Blog 1

"10. All Assam Super Deluxe Contract Carriage. (Annual Tax)

Rs. 50,000.00

Rs. 12,500.00 (Quarterly Tax)"

Repeal and 3. (1) The Motor Vehicles Taxation (Amendment) Ordinance, 2003 is hereby repealed.
