THE ASSAM APPROPRIATION (No. III), ACT, 1977

An

Act

to provide for the authorisation of appropriation of moneys out of the Consolidated Fund of the State of Assam to meet the amounts spent on certain services during the financial year ended on the 31st day of March, 1967, in excess of the amount authorised or granted for the said services.

It is hereby enacted in the Twenty-eighth Year of the Republic of India as follows:—

Short title. 1. This Act may be called the Assam Appropriation (No. III) Act, 1977.
