(Received the assent of the President on 12th April, 1978) THE ASSAM PUBLIC PREMISES (EVICTION OF UNAUTHORISED OCCUPANTS) (AMENDMENT) ACT, 1977

> An Act

to amend the Assam Public Premises (Eviction of Occupants) Act, 1971.

Preamble.

Whereas it is expedient to amend the Assam Assam Act Public Premises (Ev.ction of Unauthorised Occupants) Act, 1971, hereinafter called the principal Act, in the manner hereinafter appearing;

It is hereby enacted in the Twenty-eighth year of the Republic of India as follows :-

1. (1) This Act may be called the Assam extent and Public Premises (Eviction of Unauthorised commence- Occupants) (Amendment) Act, 1977. ment.

- (2) It shall have like extent as the principal Act.
- (3) It shall come into force on the first of the date or dates on which either the whole or any part of the principal Act comes into force.

No Civil Court shall have jurisdiction Jurisdiction. to entertain any suit or proceeding in respect of eviction of any person who is in unauthorised occupation of any public premises or the recovery of the arrears of rent payable under subsection (1) of Section 7 or the damages payable under sub-section (2) of that Section or costs awarded to the Government of Assam under subsection (5) of Section 9 or any portion of such rent, damages or costs".
