

Preamble.

Whereas it is expedient further to amend the Assam Electricity Duty Act, 1964, hereinafter referred to as the principal Act, in the manner hereinafter appearing;

Assam Act XXX of 1964.

It is hereby enacted in the Fifty-eighth Year of the Republic of India as follows:—

Short title, extent and commencement. 1. (1) This Act may be called the Assam Electricity Duty (Amendment) Act, 2007.
